- ❖ Candidate should be a bonafide of UPL University of Sustainable Technology.
- ❖ T&P Registration process will be initiated after 15 days of announcement of following results,
 - ✓ For **UG** students :
 - After Sem- 6 and all backlog results (for CAT-A)
 - After Sem-7 and all backlog results (for CAT-B)
 - ✓ For **DE & BSc** students :
 - After Sem-4 and all backlog results (for CAT-A)
 - After Sem-5 and all backlog results (for CAT-B)
 - ✓ For **MSc & PG** students :
 - After Sem-2 result (for CAT-A)
 - After Sem-3 all backlog results (for CAT-B)
- ❖ Student has to pay Rs. 5000/- as a security deposit & registration fee out of which Rs. 1000 /- is non-refundable which is the processing fee & Rs. 4000/- is the security Deposit which is refundable. The registration process is compulsory for getting Placement.
- ❖ Experience certificate showing successful completion of one year from the industry wherein student is placed through T&P Cell and in case he/she will join other company other than placed company, he /she will not eligible to get deposit back.
- ❖ **CAT-A** Candidate would get the first priority for placement if CAT-A student will not show interest then **CAT-B** Candidate will get a chance to appear.
- ❖ Every registered Candidate will get 100% placement assistance from T&P Cell (WeNayak).
- ❖ If a Candidate rejects the offer after being selected, he/she would be considered as a placed candidate.
- ❖ Once a Candidate is placed, he/she would not get other chance to appear for next interviews.
- ❖ Candidates cannot drop out from selection process once he/she has been shortlisted for further rounds after clearing first screening round.
- ❖ Interview dress code will be formal: Black pant, White shirt, Black shoe & Blazer and every registered student must follow this.
- ❖ Student will abide to all the rules and regulations of T&P cell.

- ❖ on submission of the following documents,
 - ✓ Original deposit receipt of 5000/-.
 - ✓ Certification of successful completion of one year in industry where the student was placed by T&P cell.
- c) In the following cases candidate will be disqualified/Terminated from T&P cell & further placement opportunities,
- ❖ Candidate denies to appear for three industries with salary of Rs. 15,000/- for UG / PG / MSc and for Diploma /BSc salary of Rs. 12,000/- or more than that, No refund of security deposit shall be given.
 - ❖ Violation of assigned Dress code at the time of interview.
 - ❖ Candidate appeared in five campus interviews but not selected in that case he/she's will be disqualify from T&P cell No refund of security deposit shall be given.
 - ❖ Attendance is less than 85% in any T&P activity.
 - ❖ Misbehavior in and out of the UPL university campus.
 - ❖ Unfair means (UFM) in exam.
 - ❖ Culprit in any Discipline case.
- d) T&P Cell hold a right to recommend not selecting a student in case he/she fails to remain
Eligible (as per T&P policy) after being selected.
- e) In case of indisciplinary or illegal activity during placement process, the decision of T&P cell & Management of UPL University of sustainable Technology will be final.
